Associations' Cancellation and Refund policy:

Due to the short term of most of the course offerings cash refunds are not given.

However, the school does offer the following exception:

Request for cancellation of a course offering or course offering change must be made by the student in writing.

The request must be received by the Association not less than eleven days prior to the original start of the class offering as contained on the enrollment application. If no date is indicated on the application by the student the start date shall appear as the next start of the requested course.

Request for refund received within ten or fewer days will be given as a credit for future course offerings only. Request for course offering start date change received within ten or fewer days will be charge a \$25 fee.

Non-attendance does not constitute a request for a refund. If a request for cancellation is granted any retained charges of the Association along with a \$25 cancellation fee will be deducted from the cancellation refund amount.
